MARDEN SUSCO for Item 2 at \$37.75 each and Item 3 at \$50.30 each; terms 2% 20 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with price increases not to exceed the prices in effect for the previous contract period by more than 15%.
