INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of GREASE TREATMENT FOR RAW SEWAGE as may be required for a period of one (1) year beginning April 15, 1989 through April 14, 1990, at a cost of \$13.98 per pound, for a total estimated cost of \$100,656.00; terms net 30 days, plus applicable California sales tax; with options to renew contract for four (4) additional one (1) year periods, with price escalation not to exceed prices in effect for the previous contract period by more than 10%.
