RESOLUTION NUMBER R- 273333

ADOPTED ON MAY 1 1989

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of MBC APPLIED ENVIRONMENTAL SCIENCES, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SORTING OF OCEAN BENTHIC SAMPLES as may be required for a period of one (1) year beginning June 1, 1989 through May 31, 1990 at a cost of \$145.00 per sample, for a total estimated cost of \$52,000.00 per year; terms net 30 days; with options to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed 10% of prices in effect at the end of each year.

BE IT FURTHER RESOLVED that in the event the contractor fails to perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate the contract and to reaward to the next low responsible and responsive bidder, and to subsequent low bidders, if necessary, until a bidder is found who does perform to specifications.
