

RESOLUTION NUMBER R- 273348

ADOPTED ON MAY 1 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to execute an agreement with the U.S. Department of Housing and Urban Development (HUD) in the amount of \$10,460,000 for the City's 1989 Entitlement under the Community Development Block Grant (CDBG) Program, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR -273348.

BE IT FURTHER RESOLVED, that in compliance with the National Environmental Policy Act (NEPA), California Environmental Quality Act (CEQA), HUD/CDBG and State EIR guidelines, the City of San Diego, as lead agency has determined that execution of this Grant Agreement is not subject to environmental review. Environmental reviews will be completed for specific projects prior to the request for release of funds.
