WHEREAS, this City Council has taken bids for the construction of certain improvement work within an area of the City designated "Assessment District No. 4029"; and

WHEREAS, the bid of Mur-vic Construction Company in the amount of \$1,655,597.45 is the best bid submitted in accordance with the notice inviting bids and is acceptable to this City Council; NOW, THEREFORE,

The City Council of The City of San Diego, California, DOES HEREBY FIND, RESOLVE, DETERMINE and ORDER, as follows:

Section 1. Award of Contract. That a contract be awarded to Mur-vic Construction Co., for the work and improvements described in said notice inviting bids for said Assessment District No. 4029.

Section 2. Execution and Delivery. That the City Manager is hereby authorized and directed to take such actions as may be necessary to effect said contract.

Section 3. Filing with City Clerk. That an executed copy of such contract shall be placed on file with the City Clerk along with the appropriate contractor's bonds.

Section 4. Ratification of Prior Actions. That all actions heretofore taken in connection with the awarding of said contract and other matters related thereto are hereby approved, ratified and confirmed.

Section 5. Repeal of Inconsistent Resolutions. Any resolution of the City and any part of such resolution inconsistent with this resolution is hereby repealed to the extent of such inconsistency.
