RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, AUTHORIZING EXPENDITURES FOR THE PURPOSE OF PAYING ASSESSMENTS FOR CITY-OWNED PROPERTY, MAKING GENERAL CONTRIBUTIONS TO ASSESSMENT DISTRICT NO. 4029, PAYING ASSESSMENTS FOR WATER UTILITY-OWNED PROPERTY, AND MAKING A CONTRIBUTION TO ASSESSMENT DISTRICT NO. 4029 FOR CONSTRUCTION OF CERTAIN SEWER WORK.

Sorrento Valley Road - Sorrento Valley Boulevard to

WHEREAS, the City Council has heretofore taken proceedings pursuant to the Municipal Improvement Act of 1913, Division 12, of the Streets and Highways Code, and its Resolution of Intention, Resolution No. R-273086, for the acquisition and construction of certain street and sewer improvements (the "Project") within a portion of said City designated as Assessment District No. 4029; and

WHEREAS, pursuant to said Resolution of Intention and the Engineer's Report made by the Superintendent of Streets, the City is obligated to pay assessments on City-owned property and water utility-owned property, and the City Council has declared its intent to make contributions to Assessment District No. 4029 for construction of certain sewer work and general contributions to said Assessment District; NOW, THEREFORE,

The City Council of The City of San Diego, California, DOES HEREBY FIND, RESOLVE, DETERMINE and ORDER, as follows:

Section 1. Expenditures for Assessments to City-Owned Property; General Contribution. The expenditure of an amount not to exceed \$905,000 from C.I.P. No. 52-304, Sorrento Valley Road, Sorrento Valley Boulevard to I-805, for the purpose of paying assessments to City-owned property in Assessment District No. 4029 and making a general contribution to said Assessment District is hereby authorized.


Section 2. Expenditures for Performance of Certain Sewer Work in Assessment District No. 4029. The expenditure of an amount not to exceed \$184,228 from C.I.P. No. 44-001, annual allocation for sewer main replacements, for the purpose of performing sewer main work related to the Project.

Section 3. Expenditures for Assessments to Water Utility-Owned Property. The expenditure of an amount not to exceed \$35,434 from sewer revenue fund 41506, Dept. 700, Org. 203 for the purpose of paying assessments to water utility-owned land.

Section 4. Repeal of Inconsistent Resolutions. Any resolution of the City and any part of such resolution

inconsistent with this resolution is hereby repealed to the extent of such inconsistency.
