RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, ORDERING CHANGES IN  
PROCEEDINGS TAKEN PURSUANT TO THE MUNICIPAL  
IMPROVEMENT ACT OF 1913, DIVISION 12, OF THE  
STREETS AND HIGHWAYS CODE.

(Assessment District No. 4029  
Sorrento Valley Road - Sorrento Valley Boulevard to  
I-805)

WHEREAS, this City Council has heretofore taken proceedings pursuant to the Municipal Improvement Act of 1913, Division 12, of the Streets and Highways Code, and its Resolution of Intention, Resolution No. R-273086, for the acquisition and construction of certain street and sewer improvements within a portion of said City designated Assessment District No. 4029; and

WHEREAS, pursuant to said Resolution of Intention the Superintendent of Streets duly prepared and filed a report as required by said Municipal Improvement Act of 1913; and

WHEREAS, this City Council duly called for a public hearing to be held on said Resolution of Intention and said report; and

WHEREAS, upon the basis of information brought to the attention of this City Council at said hearing, it is determined that the public interest requires that certain changes be made in said report; and

WHEREAS, the provisions of Section 10352 of said Streets and Highways Code provide that such changes may be ordered without further notice and hearing; NOW, THEREFORE,

The City Council of The City of San Diego, California, DOES  
HEREBY FIND, RESOLVE, DETERMINE And ORDER as follows:


Section 1. That the recitals set forth hereinabove are true  
and correct in all respects.

Section 2. That changes as set forth on Exhibit A, attached  
hereto, are hereby ordered and the Superintendent of Streets is  
hereby authorized and directed to cause said changes to be  
reflected in the report and specifically in the proposed  
assessment and assessment diagram included in said report.

Section 3. Any resolution of the City and any part of such  
resolution inconsistent with this resolution is hereby repealed  
to the extent of such inconsistency.
