RESOLUTION NUMBER R- 273374

ADOPTED ON MAY 2, 1989

WHEREAS, on January 12, 1989, the Planning Commission of The City of San Diego held a public hearing for the purpose of considering the College Area Community Plan (an update of the 1974 State University Area Plan); and

WHEREAS, the College Area Community Plan recommends that the College Area Community should remain a predominantly residential community of the City of San Diego, and that land use and transportation conflicts between San Diego State University and the residential neighborhoods of the community should be minimal; and


WHEREAS, the continued increase of enrollment at San Diego State University may contribute to the continuance or increase of such conflicts; and

WHEREAS, the Council of The City of San Diego held a public hearing and considered all maps, exhibits, and written documents contained in the file for this plan, on record in the City of San Diego, and considered all oral presentation given at the public hearing as well as discussion by the Planning Commission; and

WHEREAS, the Council of The City of San Diego finds that enrollment increases at San Diego State University may contribute to adverse land use and transportation impacts in residential neighborhoods of the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said Council recommends to the Board of Trustees of the California State University that future enrollment at San Diego State University be limited to a level not to exceed the enrollment of the 1988 fall term, and that, further, the Board of Trustees make every effort to reduce future enrollment at San Diego State University from the level of the 1988 fall term.
