RESOLUTION NUMBER R- 273386

ADOPTED ON MAY 2 1989

WHEREAS, San Onofre Nuclear Reaction Unit # 1 first began commercial operation on January 1, 1968; and

WHEREAS, this reactor is the oldest licensed nuclear plant in the state; and

WHEREAS, recent newspaper reports indicate considerable damage to the thermal shield; and

WHEREAS, regulatory engineers are concerned that further vibration of the shield could cause support blocks to slip; and

WHEREAS, in a worst case scenario (envisioned by NRC staff) this could cause the shield to drop to bottom of the reactor, affecting the flow of cooling water around the reactor core itself; and

WHEREAS, Southern California Edison Corp. has plans to resume operations of the Unit # 1 Reactor at San Onofre without repairing the thermal shield damage; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, out of concern for the safety of its citizens, that this Council, for and on behalf of all citizens, requests that San Onofre Unit # 1 Reactor not be permitted to resume operations until all questions regarding its safety have been resolved.

BE IT FURTHER RESOLVED, that this Council directs that our congressional delegation be requested to intervene as may be necessary and appropriate to assure that the safety of our citizens is not jeopardized.
