BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon receipt of \$48,000 in grant funds from State of California Grant Funds (Proposition 18), as required by the granting agency, is hereby authorized to allocate these funds for the hereinabove described purpose.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$9,118 (\$2,133 from PSD Fund No. 11690 and \$6,985 from Special Park Fee Fund No. 39089) to CIP No. 29-658 SKYLINE COMMUNITY PARK - LIGHTING.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$105,018 (\$55,500 from PSD Fund. No. 11432, CIP No. 29-564 KEARNY MESA COMMUNITY PARK - LIGHTING; \$40,400 from PSD Fund No. 11222, CIP No. 29-567 MIRA MESA COMMUNITY PARK - LIGHTING and \$9,118 from CIP No, 29-658 SKYLINE COMMUNITY PARK - LIGHTING), is hereby

authorized solely and exclusively for providing funds for said project and related cost, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
