RESOLUTION NUMBER R- 273400


ADOPTED ON MAY 08 1989

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the authority delegated to the City under California Vehicle Code section 35700 et seq., commercial vehicles with a gross vehicle weight rating of over 5,000 pounds, be and the same are hereby prohibited from operating on Kelton Road (Highway 94 to Alvin Street).

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
