WHEREAS, the program's purpose is to encourage equal contracting opportunities for businesses owned, operated and daily managed by minorities and women; and

WHEREAS, the provisions extend to the City's five (5) Independent Corporations; and

WHEREAS, the program complies with City Charter Sections 35 and 94 which require that the award of contracts for construction, goods, materials, and services be made through a competitive process to the lowest, responsible bidder; and

WHEREAS, the City Manager submits a Quarterly Equal Opportunity Status Report to reflect the progress made as a result of the program; and

WHEREAS, said report was submitted to and considered by the Rules Committee on April 19, 1989 and approved unanimously; and

WHEREAS, it is now necessary to forward said Status Report to the full Council for acceptance and approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager's Equal Opportunity Status Report, Report No. 89-188, dated April 17, 1989, considered and approved by the
