BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$19,250 from Penasquitos Canyon Preserve Park Fund No. 10582 to CIP No. 29-428, Los Penasquitos Canyon Preserve.


