

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue two checks; one check in the amount of \$145,000.00 made payable to Roy Anthony Mason and Irwin Gostin, his attorney; and one check in the amount of \$155,000.00 made payable to P.L. Assigned Services, Inc., in full settlement of the lawsuit and of all claims.
