WHEREAS, the proposed amendment to the Progress Guide and General Plan for The City of San Diego will not become effective until adopted by the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that said amendment to the Progress Guide and General Plan for The City of San Diego be, and the same is hereby adopted.


