ADOPTED ON MAY 15 1989

WHEREAS, the Commission through the Department has provided funding of over \$14 million for boating in San Diego County; and

WHEREAS, the development of Mission Bay for recreational boating has been aided by grants totalling \$1,611,000; and

WHEREAS, the San Diego City Lakes Recreation Program has been greatly enhanced by previous grants and promised grants totalling \$2,937,000 at Hodges, Miramar, Sutherland, El Capitan, San Vicente, and Otay reservoirs; and
