RESOLUTION NUMBER R- 273456

ADOPTED ON MAY 15 1989

APPROVING MAP OF CARMEL DEL MAR NEIGHBORHOOD 5
UNIT NO. 10.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Jeffrey R. Lundstrom, Registered Civil Engineer, entitled "CARMEL DEL MAR NEIGHBORHOOD 5 UNIT NO. 10 being a subdivision of a portion of Parcels 26 and 29 through 33 inclusive, of Parcel Map No. 12871, in the City of San Diego, County of San Diego, State of California, according to the parcel map thereof filed in the Office of the County Recorder of San Diego County, August 26, 1983, together with a portion of the Southwest Quarter of the Northwest Quarter of Section 20, Township 14 South, Range 3 West, San Bernardino Base and Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Saluto Court, Mona Lisa Street, Mercurio Street, Campobello Street and Del Mar Trails Road, together with a pedestrian and non-motor vehicle right-of-way and said streets are hereby declared to be public streets and public pedestrian and non-motor vehicle right-of-way and dedicated to the public

use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Carmel Country Road, adjacent and contiguous to Lots 30 through 44 inclusive, and a portion of Lot 45; in and to Del Mar Trails Road, adjacent and contiguous to Lots 4, 5, 6, 29, 30 and Lots 71 and 72, all as shown on the map within the subdivision.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs 2 through 4 of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and pedestrian and non-motor vehicle right-of-way, together with those certain abutters' rights of access are accepted on behalf of the public as heretofore stated; that those easements listed in paragraphs 2 through 4 of the Owner's Certificate, as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.
