
ADOPTED ON MAY 15 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Sixth Amendment to the Joint Powers Agreement with THE SOUTHERN CALIFORNIA COASTAL WATER RESEARCH PROJECT AUTHORITY, to extend the agreement to June 30, 1990 and increases the maximum amount due annually, under the terms and conditions set forth in the Sixth Amendment to Joint Powers Agreement on file in the office of the City Clerk as Document No. RR- 273470 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$128,000 from the Sewer Revenue Fund (No. 41506), is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above sixth amendment to the Joint Powers Agreement.
