RR- 273474 , be, and the same is hereby authorized to be

sold by negotiation for the amount of SEVENTY-FIVE THOUSAND DOLLARS (\$75,000) to CLAIREMONT CHURCH OF CHRIST.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No.

RR-273474, granting to CLAIREMONT CHURCH OF CHRIST all that portion of Pueblo Lot 1210 of the Pueblo Lands of San Diego, as more particularly described in the grant deed.

- That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver the grant deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
