WHEREAS, the provisions of Council Policy No. 600-15 require that a noticed public hearing be conducted before the Council of The City of San Diego prior to the vacation of a city street; and

WHEREAS, the vacation of Amber Crest Drive, a portion of Shadow Oaks Court, and the water easement within Lot 1 of Map 11915 have been initiated by the submission of a tentative map; and

WHEREAS, Section 66499.20 of the California Government Code provides that the filing of the map shall constitute abandonment of all streets and easements not shown on said map; and

WHEREAS, the proposed subdivision, Carmel Mountain Ranch
Units 4, 4A, and 36 (TM 87-0639) contains Amber Crest Drive, a
portion of Shadow Oaks Court, and a water easement within Lot 1
of Map 11915, which are rights-of-way that are no longer required
for street or water purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Amber Crest Drive, a portion of Shadow Oaks Court, and the water easement in Lot 1 of Map 11915, all within the subdivision boundaries of Carmel Mountain Ranch Units 4, 4A, and 36 (TM 87-0639), as more particularly shown on Exhibit "A," on file in the Office of the City Clerk as Document No. $RR-\frac{273492}{492}$, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered, vacated.

- 2. That this Resolution shall not become effective unless and until the final subdivision map for Carmel Mountain Ranch Units 4, 4A, and 36 (TM 87-0639) has been approved by Council action. In the event that final subdivision map TM 87-0639 is not approved six years after adoption of this Resolution, this Resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the completion of the aforementioned subdivision map, and the City Clerk shall then cause a certified copy of this Resolution, with Exhibit "A," attested by him under seal, to be recorded in the Office of the County Recorder.



