TRENCH PLATE RENTALS as may be required for a period of one (1) year beginning April 25, 1989 through April 24, 1990, per prices on file in the Purchasing Department, as follows:

1. ALLIED BARRICADE COMPANY, INC. - Primary contract; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods, option year price increases not to exceed the prices in effect at the end of the previous contract year by more than 10%.
2. TRENCH PLATE RENTAL CO. - Secondary "Back-up" contract; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods, with no price increases in the first two (2) option years and maximum 6% and 4% price increases in the third and fourth option years, respectively.
