RESOLUTION NUMBER R- 273530

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim the week of May 21 through 27, 1989 as NATIONAL PUBLIC WORKS WEEK in San Diego and call upon all citizens and civic organizations to acquaint themselves with the problems involved in providing public works and to recognize the

contributions which public works officials make every day to our health, safety and comfort.
