BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of THE CITY OF SAN DIEGO, an Amendment to Subdivision Improvement Agreement for EUCLID OAKS, on file in the office of the City Clerk as Document No. RR-257090, to provide for the substitution of AVANTI DEVELOPMENT, INC., for ALLEN HALL DEVELOPMENT CORPORATION, a California corporation, as subdivider.

2. That the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by September 30, 1990, as provided in the Amendment to Subdivision Improvement Agreement, on file in the office of the City Clerk as Document No. RR- 273533.

3. That Bond No. 113 21 01, issued by Explorer Insurance Company, in the amount of \$128,000 is hereby accepted as the surety for the required improvements in the subdivision, is substituted as Exhibit C to the agreement, and Bond No. 2SM 563 692, issued by American Motorists Insurance Company, in the amount of \$100,143, is hereby released.
