RESOLUTION NUMBER R- **273534**

ADOPTED ON MAY 22 1989

WHEREAS, the City Council supports the development of quality, affordable child care for all citizens of San Diego; and

WHEREAS, the City Council also supports the development of public/private partnerships in the creation of child care facilities; and

WHEREAS, the City Council has previously directed through Council Policy 300-12, that the City will cooperate with agencies, organizations, and individuals in the private and public sectors who are endeavoring to meet the need for child care services in the City of San Diego; and

WHEREAS, Mr. Edward B. Romanow, Jr., of Westerra Pacific Associates has generously offered to provide a voluntary contribution of one hundred thousand dollars (\$100,000) for the development of a child care facility in Eastgate Technology Park tentatively identified as Lot 1; and

WHEREAS, the City is interested in working with Mr. Romanow in the development of the child care facility; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council does commend and accepts the generous offer of one hundred thousand dollars (\$100,000), from Mr. Edward B. Romanow, Jr., of Westerra Pacific Associates to be used for child care development in the Eastgate Technology Park area and hereby directs the City Manager to work with and negotiate ground lease

terms for Lot 1, of Eastgate Technology Park and to return to this Council within a ninety (90) day period with recommendations on a course of action which will allow for an additional child care facility to be established in the Eastgate area.
