WHEREAS, the San Dieguito River Valley Project is a significant regional park and open space project for The City of San Diego; and


WHEREAS, on May 17, 1989, the Rules Committee considered the Intergovernmental Relations Department Report No. 89-22 discussing legislation affecting the project; specifically SB 546 (Craven), AB 2356 (Sher), AB 145 (Costa), AB 1416 (Killea) and SB 1053 (Alquist); and

WHEREAS, the Rules Committee concurs with and approved the recommendations contained in Intergovernmental Relations Department Report No. 89-22 supporting this legislation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Intergovernmental Relations Department be and it is hereby directed to express the City's support for legislation relating to the San Dieguito River Valley Project to the appropriate state legislators and the Governor, and direct that the City's lobbyist in Sacramento continue to work with the authors to ensure that San Diego's interests are included in the final language.
