RESOLUTION NUMBER R- 273540

ADOPTED ON MAY 22 1989

WHEREAS, several years ago the United States Customs Service purchased property on Otay Mesa and established an international border crossing for all incoming commercial traffic; and

WHEREAS, all southbound (outgoing) traffic continues to use the Virginia Street Gate in San Ysidro; and

WHEREAS, the United States Customs Service has recently acquired an additional 16-acre site to expand its operations on Otay Mesa; and

WHEREAS, truck traffic using the southbound commercial gate at Virginia Street in San Ysidro has become a safety hazard and is a highly disruptive element to the residents and merchants in the community; and

WHEREAS, the trucks are parked throughout the residential streets of the community, they create noise and air pollution, and create traffic congestion with lines of trucks waiting to cross the border often extending for over a mile; and


WHEREAS, the closure of the Virginia Street truck crossing is supported by a broad cross-section of the community, including the San Ysidro Planning and Development Group, the San Ysidro School District and the Adelante Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby request the federal government to enter into discussions and negotiations with the Republic of Mexico to
