RESOLUTION NUMBER R- 273541

ADOPTED ON MAY 22 1989

WHEREAS, traffic congestion on a State level has led to California motorists spending approximately 200,000 hours a day waiting in traffic jams; and

WHEREAS, congestion on Interstate 5 in the Sorrento Valley area during rush hour is increasing at an alarming rate, and

WHEREAS, the traffic volumes projected in the Regional Transportation Plan adopted by SANDAG indicates the need for the dual freeway concept; and

WHEREAS, the new separated freeway lane would remove slow trucks from the high-speed automobile traffic between the I-5/I-805 junction and Carmel Valley Road; and

WHEREAS, industrial development in the Sorrento Hills and surrounding communities were planned and approved based on the dual freeway concept for Interstate 5 with an interchange at Carmel Mountain Road; and

WHEREAS, private development will dedicate or purchase all the necessary right-of-way along the entire east side of the I-805 and I-5 through this section for the dual freeway length, which is worth in excess of \$12,000,000; and


WHEREAS, existing developers in the immediate area have committed in excess of \$13,000,000 for the construction of the Interstate 5/Carmel Mountain Road interchange; and

WHEREAS, the new interchange at Carmel Mountain Road and Interstate 5 would reduce the circuitous travel and delay on local streets, and reduce congestion at both the Carmel Valley Road and the Roselle Street interchanges with I-5; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council, for and on behalf of the people of San Diego, hereby requests that the California Transportation Commission adopt the dual freeway concept as the only alternative presented that meets the identified transportation needs for this segment of Interstate 5 in the San Diego region.
