RESOLUTION NUMBER R- 273544

ADOPTED ON MAY 23 1989

A RESOLUTION OF THE CITY OF SAN DIEGO
DECLARING THE EXISTENCE OF A STATE OF
EMERGENCY WITHIN SAID CITY.

WHEREAS, The City of San Diego's inner city neighborhoods are experiencing a rash of drug related and gang related drive-by shootings; and

WHEREAS, such occurrences have increased to a frequency which has alarmed the citizenry of San Diego and constitute a clear and present state of emergency; and

WHEREAS, San Diego currently spends 42% of the law enforcement budget on drug related enforcement and is in dire need of financial assistance to meet and control this menace to health, safety and welfare; and

WHEREAS, the Mayor of The City of San Diego, pursuant to the authority of the Charter of The City of San Diego and San Diego Municipal Code section 51.0106 has determined and proclaimed that a state of emergency exists; and

WHEREAS, pursuant to section 8558(c) of the California Government code, this war on drugs is "beyond the control of the services, personnel, equipment and facilities of the political subdivision" of The City of San Diego; and

WHEREAS, pursuant to the California Government Code, section 8625(b), the Governor may be requested to proclaim a state of emergency in the area affected; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the declaration by the Mayor of The City of San Diego, pursuant to the authority of the Charter of The City of San Diego and section 51.0106 of the San Diego Municipal Code, that a state of emergency exists within said city be and it is hereby approved.

BE IT FURTHER RESOLVED, that pursuant to section 8625(b) of the California Government Code, the Governor of California is hereby requested to proclaim a state of emergency in San Diego.
