RESOLUTION NUMBER R- 273545

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on May 4, 1989 to consider approving and recommending City Council adoption of a map classifying protected single-family neighborhoods in the Carmel Mountain Ranch, Miramar Ranch North, Navajo, North City West, Ocean Beach, Old San Diego, Otay Mesa, Rancho Bernardo, Rancho Penasquitos, Sabre Springs, Scripps Miramar Ranch, Serra Mesa, Sorrento Hills, Torrey Pines, University City, and Via de La Valle Community Planning Areas; and

WHEREAS, the City has adopted the Single-Family Protection Ordinance (O-17250) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, the City recognized community planning group for each of the above listed communities, which has a planning group, has voted to approve the applicable protected single-family neighborhood maps for that community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations of the Planning Department, as set forth in Planning Report No. 89-214, approving and adopting a map classifying protected single-family neighborhoods in the Carmel Mountain Ranch, Miramar Ranch North, Navajo, North City West, Ocean Beach, Old San Diego, Otay Mesa, Rancho Bernardo, Rancho Penasquitos, Sabre Springs, Scripps Miramar Ranch, Serra Mesa,
