RESOLUTION NUMBER R-273546

ADOPTED ON MAY 23, 1989

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on May 4, 1989 to consider approving and recommending City Council adoption of a map classifying protected single-family neighborhoods in the Barrio Logan, Centre City, East Elliott, Fairbanks Country Club, Kearny Mesa, Midway, Mission Beach, Mission Valley, San Pasqual, and Tia Juana River Valley Community Planning Area, and adopted the Single-Family Protection Ordinance (O-17250); and

WHEREAS, the City has adopted the Single-Family Protection Ordinance (O-17250) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and


WHEREAS, no neighborhoods have been identified in the above listed planning area which are primarily single-family in character; and

WHEREAS, the City recognized community planning group for each of the above listed communities, which has a planning group that has considered the neighborhood protection issue, has voted that no neighborhoods in this community should be classified as protected single-family neighborhoods; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations of the Planning Commission, as set forth in Planning Report No. 89-214, that no areas in the communities of Centre City, East Elliott, Fairbanks Country Club, Kearny Mesa,

Midway, Mission Valley, San Pasqual, and Tia Juana River Valley
Community Planning Area be classified as protected single-family
neighborhoods and that all the communities in their entirety be
and are hereby released from the provisions of the Single-Family
Protection Ordinance (O-17250).
