RESOLUTION NUMBER R-273553

ADOPTED ON MAY 23, 1989

WHEREAS, on May 17, 1989, the Rules Committee reviewed Intergovernmental Relations Department (IRD) Report No. 89-24, dated May 12, 1989 and recommended that the City oppose SB 705 (Stirling) and AB 1035 (Bentley) citing the issue of local control as most important in the siting of regional jail facilities; and

WHEREAS, at its meeting of May 22, 1989, the City Council is requested to approve the recommendation of the Rules Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Intergovernmental Relations Department be directed to express to the appropriate state legislators and to the Governor the City's opposition to SB 705 (Stirling) and AB 1035 (Bentley) relating to a state mandate to close local jail facilities.

BE IT FURTHER RESOLVED, that the County of San Diego be and it is hereby encouraged, through its Master Plan, to commit to a date that would either call for the removal or replacement of the local jail facilities with a permanent facility by 1996.
