BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. SAFETY WEST, 2. VALLEN SAFETY SUPPLY CO., 3. CALOLYMPIC GLOVE AND SAFETY CO., 4. G. S. PARSONS COMPANY, and 5. PACIFIC SAFETY EQUIPMENT CO., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing GLOVES as may be required for a period of one (1) year beginning May 1, 1989 through April 30, 1990, per prices on file in the Purchasing Department, with options to renew contracts for one additional one (1) year period as follows:

1. SAFETY WEST for Items 1, 2, 3, 14, 15, 16, 17, 18, 23, 24 and 25, for a total estimated cost of \$20,155.45; terms 1% 20 days, plus sales tax.
2. VALLEN SAFETY SUPPLY CO. for Items 4, 13 and 19, for a total estimated cost of \$2285.90; terms 1% 20 days, plus sales tax.
3. CALOLYMPIC GLOVE AND SAFETY CO. for Items 5, 6, 7 and 8, for a total estimated cost of \$4092.90; terms net 30 days, plus sales tax.
4. G. S. PARSONS COMPANY for Items 9, 10, 11 and 12, for a total estimated cost of \$6390.45; terms net 10th prox., plus sales tax.
5. PACIFIC SAFETY EQUIPMENT CO. for Items 20, 21 and 22, for a total estimated cost of \$31,822.62; terms 2% 20 days, plus sales tax.
