WORKING HEIGHT for a period of one (1) year beginning June 1, 1989 through May 31, 1990 at a cost of \$2,284.63 per month, for a total cost of \$27,415.56; terms net 20 days, plus sales tax, plus a delivery charge of \$1,800.00 and a return charge of \$1,800.00; with options to renew the rental on a month-to-month basis for two (2) years, and options to buy at the end of each contract year, per prices on file in the Purchasing Department.
