WHEREAS, the Council has previously authorized the use of funds from the Seized and Forfeited Assets Program in order to fund the Police Helicopter Program;

NOW THEREFORE,

BE IT RESOLVED, By The Council of The City of San Diego, as follows:

1. That the Purchasing Agent of The City of San Diego, be and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for services of a vendor or vendors to furnish a "police helicopter transmission" in accordance with original bid specifications.

2. That the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder or bidders to furnish the "police helicopter transmission."

3. That the expenditure, not to exceed \$60,000 from Fund 10132, Job Order 00201, is hereby authorized solely and exclusively for providing funds for said project and related costs.
