WHEREAS, in Closed Session on May 2, 1989, the City Council, by the following vote: Yeas, Districts 1, 2, 3, 4, 6, 7, and the Mayor; Not Present, Districts 5, and 8, approved the settlement of Superior Court Case No. 542573, Ali Tashkorian, et al. v. City of San Diego, et al. in the amount of \$406,000.00 as to all parties,

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$406,000.00 as to plaintiffs Ali and Esmet Tashkorian and Plaintiff-In-Intervention National American Insurance Company in the settlement of their claims against The City of San Diego, its agents and employees, in Tashkorian, et al. v. City of San Diego, et al., Superior Court Case No. 542573 for damages due to land subsidence to the real property at 1588 Nautilus Street, San Diego.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$406,000.00, made payable to Ali and Esmet Tashkorian and their attorney of record Richard Elliott of McInnis, Fitzgerald, Rees, Sharkey & McIntyre in full settlement of the lawsuit and of all claims.


