WHEREAS, IMAA is known for its commitment since its inception in 1975 to the challenging task of community organization and leadership development for the refugee community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the week of May 22 through 26, 1989 be declared "REFUGEE MUTUAL ASSISTANCE ASSOCIATION RECOGNITION WEEK" in The City of San Diego in recognition of the dedicated and inspiring work being accomplished by the Indochinese Mutual Assistance Association of San Diego on behalf of the refugee population.
