ADOPTED ON MAY 30 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a twenty-five (25) year lease agreement with the San Diego Unified School District for the lease, development and maintenance of a portion of Wilson Middle School Site for Park and Recreation Department purposes, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-273611.

BE IT FURTHER RESOLVED, that CIP No. 29-698, Wilson Middle School-Turfing, is hereby added to the 1989 Capital Improvement Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$400,000 from CDBG Fund No. 18525 to CIP No. 29-698, Wilson Middle School-Turfing.


BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$400,000 from CIP No. 29-698, CDBG Fund No. 18525, is hereby authorized, solely and exclusively for the purpose of providing funds for designing and constructing turf improvements at Wilson Middle School.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to remit unexpended funds, if any, to the appropriate reserves upon advice of the administering department.

BE IT FURTHER RESOLVED, that the San Diego Unified School District is hereby requested to administer contracts for the design and construction of turf and irrigation improvements at Wilson Middle School in an amount not to exceed \$400,000.
