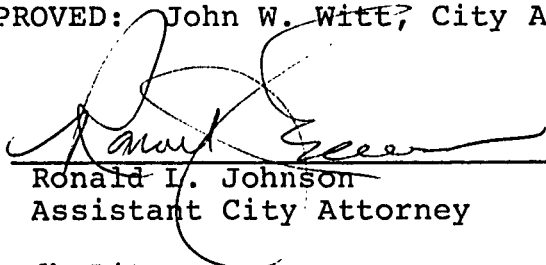
RESOLUTION NUMBER R-273613
