ADOPTED ON MAY 30 1989

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER TO NEGOTIATE A COOPERATIVE AGREEMENT WITH CALTRANS FOR THE STATE ROUTE 15 MID-CITY PROJECT.

WHEREAS, ON May 14, 1985, the Council of The City of San Diego and the California Department of Transportation (Caltrans) approved a Freeway Agreement and a Memorandum of Agreement for the State Route 15 Project in Mid-City; and

WHEREAS, said agreements established the design parameters and the respective responsibilities of The City of San Diego and Caltrans for the State Route 15 Project in Mid-City; and

WHEREAS, The City of San Diego and Caltrans are mutually desirous of entering into a Cooperative Agreement to further establish the respective responsibilities of The City of San Diego and Caltrans in regards to financing proposed facilities for the State Route 15 Project in Mid-City; and

WHEREAS, a list of proposed terms for the Cooperative Agreement has been prepared and is attached hereto as Attachment 1 and incorporated herein as set forth in full; and

WHEREAS, it is agreed by The City of San Diego and Caltrans that implementation of the proposed Cooperative Agreement is subject to future budget approval by The City of San Diego and the California Transportation Commission, is subject to approval by The City of San Diego of the Mid-City Public Facilities

Financing Plan and the Mid-City Redevelopment Plan and is also subject to budget approval by the San Diego County Regional Transportation Commission; and

WHEREAS, it is agreed by The City of San Diego and Caltrans that approval of the proposed Cooperative Agreement is subject to approval by The City of San Diego and Caltrans of a mutually acceptable Memorandum of Understanding regarding design features and environmental mitigation measures for the State Route 15 Project in Mid-City; and

WHEREAS, the City Manager is able and willing to negotiate a Cooperative Agreement based on the attached list of proposed terms and subject to the constraints described herein; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego as follows:

The City Manager is hereby authorized to negotiate a Cooperative Agreement with Caltrans for the State Route 15 Project in Mid-City based on the attached list of proposed terms and subject to the constraints described herein.

Proposed Terms for a COOPERATIVE AGREEMENT for a
Project Along 40th Street on State Route 15

A Memorandum of Agreement between the City of San Diego and Caltrans was signed on May 21, 1985. A proposed Cooperative Agreement will establish details relative to responsibility for implementation of and funding for the features in the Memorandum of Agreement and a subsequent plan revision.

City agrees:

1. To fund construction of an additional cover between Landis and Wightman Streets, including improvements on top of the cover.
2. To fund construction of any special widening and enhancement of structures at University Avenue, El Cajon Boulevard and Meade Avenue beyond that related to normal vehicular and pedestrian requirements.
3. To fund any street planting, special community signs or other enhancements on the streets or approaches to structures.

State agrees:

1. To design and construct the cover to be funded by the City.
2. To design and construct special widening and enhancement of both sides of the crossing structures at University Avenue and El Cajon Boulevard and the north side of Meade Avenue.
3. To credit the City for the estimated cost of a pedestrian crossing structure at Landis Street that will not have to be constructed because the same service will be provided by the block cover being funded by the City. This credit may be applied to the widening and enhancement of a street structure in the same contract as the City block of cover.
