RESOLUTION NUMBER R-273620

ADOPTED ON MAY 30 1989

WHEREAS, The City of San Diego entered into a Basic Operating Agreement with the San Diego Data Processing Corporation (SDDPC) for data processing services, which was approved by Resolution No. R-250208, dated September 25, 1979; and

WHEREAS, by seventh amendment thereto, approved by Resolution No. R-266884, dated October 28, 1987, the agreement was amended to transfer to SDDPC the entire responsibility for telecommunication services; and

WHEREAS, the responsibility for contracting for a new telecommunications system for The City of San Diego resides with SDDPC, as authorized by the seventh amendment; and

WHEREAS, SDDPC has issued RFPs and received and opened bids for the acquisition of said new telecommunications system; and

WHEREAS, included with the entire procurement package is provision for telecommunication services for the San Diego Convention Center; and

WHEREAS, the City Council has registered concern regarding the RFP process and has expressed a desire that the SDDPC should forego negotiations with any specific vendor until a final and best offer may be sought and received; and


WHEREAS, other actions have been expressed by the Council in order to resolve the matter of procuring telecommunication services, to include bifurcating the San Diego Convention Center

portion of the package pending resolution of the rest of the matter, rescinding the entire basic operating agreement, as amended and pursuing the matter of a last and best offer; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the San Diego Data Processing Corporation be and it is hereby requested to take all necessary and appropriate action to secure a final and best response to the RFP for telecommunication services from responding vendors.
