WHEREAS, during the 1988-89 school year, The City of San Diego's Regional Youth Employment Program (REGY) operated a "Stay in School" career exploration program which served a hundred and sixty-five (165) youths; and

WHEREAS, this program was funded through a contract with the Regional Employment and Training Consortium/Private Industry Council (PIC/RETC); and

WHEREAS, the objective of this program was to familiarize youth with a variety of career options and to teach them how to prepare and qualify for entering various occupations; and

WHEREAS, in February of 1989, The City of San Diego's Park and Recreation Department initiated a Junior Lifeguard training program in cooperation with REGY which was designed to help youths learn about the lifeguard career and to become qualified as Summer Recreational Aides at City of San Diego pools; and

WHEREAS, since February of 1989, fifteen (15) youths have been trained at Martin Luther King, Jr. Pool and have earned certificates in basic rescue, first aid, C.P.R., and swimming skills; and


WHEREAS, these youths will utilize these skills this coming summer as aquatic aids for the City of San Diego; NOW, THEREFORE,
