Gayle Bates	Fire Department	\$320.00	Mr. Bates is a Firefighter. He suggested attaching a ground rod to the E.O.D. Bunker at Chollas Land fill to control static electricity. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Gregorio Martines	Water Utilities	\$160.00	Mr. Martinez is a Waste Water Plant Operator in the Metro Division. He suggested placing a canvas curtain around the hopper to guide falling materials into the rag bin. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Tami Echavarria	Library	\$160.00	Ms. Echavarria is a Librarian I. She suggested implementing a committee of bilingual children librarians that will review and choose spanish children's materials. Although savings are difficult to identify, this was considered to be a significant operational improvement.
June Allison	Fire Department	\$ 90.00	Ms. June Allison was a Firefighter at the time of this suggestion. She suggested changing stop signs used by fire engines and truck companies to reflective. Although savings are difficult to identify, this was considered to be a significant operational improvement.
