Michael Elerding	General Services	\$ 80.00	Mr. Elerding is an Equipment Mechanic. He suggested the installation of tubes on the refuse packers to hold the shovels. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Roy Knowles	Fire Department	\$ 80.00	Mr. Roy Knowles is a Captain. He suggested removing the lower holding clips from the breathing apparatus storage brackets. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Edwin Heidig	Water Utilities	\$ 50.67	Mr. Heidig is a Biologist II. He suggested using ball bearing motors in the mosquito lite traps. The estimated savings are \$1,013.30. This is a partial award pending a 12-month review.
Monica Montgomery	Risk Management	\$ 45.00	Ms. Montgomery is a Word Processing Operator. She suggested posting the City Manager Reports in a place that is accesible to all employees. Although savings are difficult to identify, this was considered to be a significant operational improvement.
