BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$100,000 from the Water Revenue Fund (No. 41502), Unallocated Reserve (No. 70679) to the Water Operating Fund (No. 41500), Administrative Services Program (No. 70613).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,000 from the Water Operating Fund (No. 41500), Administrative Services Program (No. 70613), is hereby authorized for both Fiscal Years 1989 and 1990, solely and exclusively for the purpose of implementing, in coordination with the San Diego County Water Authority, the Water Conservation Public Information and Education Program.

BE IT FURTHER RESOLVED, that in implementing the above referenced program the following areas should be pursued by staff:

a) Continue with the ongoing rate design study;

b) Explore quarterly meetings at the City of San Diego Public Services and Safety Committee to heighten public awareness and to strengthen the Water Conservation Public Information and Education Program; and
