

BE IT FURTHER RESOLVED, that an increase of \$209,173 for consultant services for the Sixth Amendment from FSDRIP, Fund 79364, is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$209,173 from FSDRIP, Fund 79364, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
