RESOLUTION NUMBER R- 273669

ADOPTED ON JUN 05 1989

WHEREAS, on May 30, 1989, the City Council considered and discussed the matter of the telecommunication services contract award process as conducted by the San Diego Data Processing Corporation (SDDPC); and

WHEREAS, the Council had before it three resolutions regarding possible courses of action the Council could pursue; and

WHEREAS, the Council acted upon two of them, specifically Resolution No. R-273618 and R-273620; and

WHEREAS, the Council's actions in those resolutions were to request SDDPC to seek a final and best offer from contract proposers and to request bifurcation of the telecommunication systems package to enable the Convention Center Corporation to press forward expeditiously; and

WHEREAS, the Council was advised and aware of the fact that it could not interfere with the contract letting process in that SDDPC had sole and exclusive responsibility for telecommunications matters; and

WHEREAS, the actions by Council were only requesting SDDPC, if it agreed, to take further actions and were not directive; and

WHEREAS, the Council's actions on these resolutions have been misconstrued as to its nature and the Council wishes to unambiguously clarify the matter to reflect its nondirective intent and role; and

WHEREAS, to accomplish that end, it is necessary to reconsider the matter, as acted and voted upon on May 30, 1989; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that item 206 on the Council docket of May 30, 1989, relating to the matter of telecommunication systems services, be and the same is hereby reconsidered.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to place the matter on the adoption agenda of the Council docket as soon as possible.
