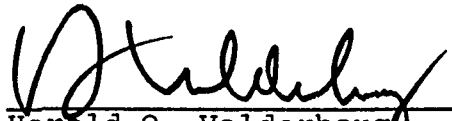
ADOPTED ON JUN 12 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of two easement deeds of GIRARD FINANCIAL CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of October 18, 1988, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR-273694-1 and RR-273694-2 granting to said City easements for public street purposes and for water and electrical facilities in Lot 4, Fashion Valley North, Map No. 9032, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for a public street, and the same is hereby named FRIARS ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
