WHEREAS, the vacation of the City's interest in an unneeded water easement affecting Lot 60 of Map No. 4392, as more particularly shown on Drawing No. 17202-B attached hereto as Exhibit A, has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has not been used for at least five years, and is surplus to City needs; and



BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the water easement, as more particularly shown on the drawing attached hereto, is hereby vacated.

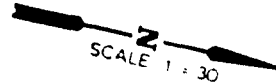

EASEMENT ABANDONMENT PLAT





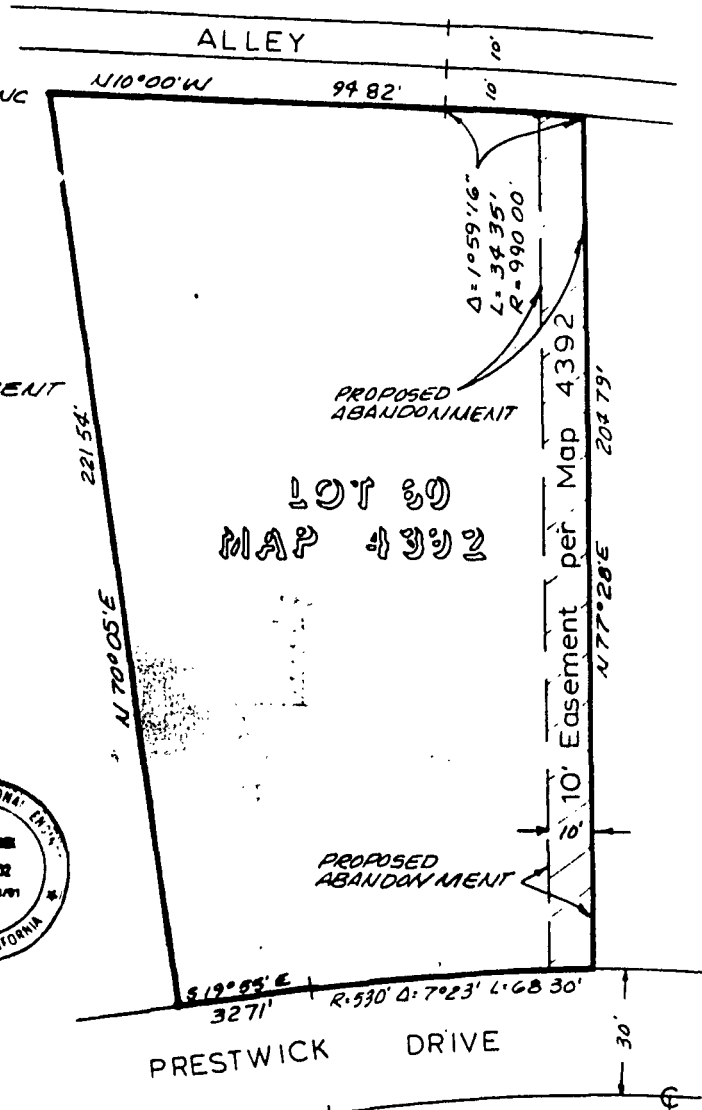
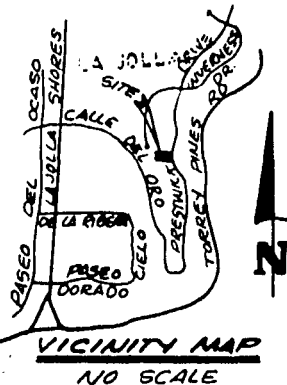
