ADOPTED ON JUN 12 1989

WHEREAS, the Naval Combat Aircraft Foundation (NCAF) is a local nonprofit entity whose principal asset is a fully restored MASH era Bell helicopter; and

WHEREAS, the helicopter flies directly to a local elementary school playground and a San Diego Charger, Padre or other prominent athlete alights and delivers a powerful anti-drug abuse message; and

WHEREAS, the theme is "YOU CAN'T FLY WHILE YOU'RE HIGH" and the program is well received at the schools; and

WHEREAS, new federal aviation administration safety regulations require this copter to add a transponder and other gear by July 1, 1989 and, without these items, costing \$2,465, this worthy program will be grounded; and


WHEREAS, budget savings are available in Council District 6 and approval of this resolution would authorize the City Auditor to reimburse NCAF for purchase of the needed electronics; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and City Auditor be and they are hereby authorized to reimburse the nonprofit Naval Combat Aircraft Foundation a sum not to exceed \$2,465 from the General Fund 100, Department 0260, for the purchase of FAA mandated electronics

equipment for a Bell helicopter, said reimbursement to be made upon submission of appropriate invoices.
