

RESOLUTION NUMBER R-273709

ADOPTED ON JUNE 12, 1989

WHEREAS, each year the San Diego Police Department sponsors the School Safety Patrol Summer Camp; and

WHEREAS, this camp is held at the Palomar County School Camp; and

WHEREAS, the School Safety Patrol Summer Camp affords sixth grade students from all elementary schools an educational growth and recreational experience; and

WHEREAS, the San Diego Unified School District has agreed to provide transportation for students to and from the camp; and

WHEREAS, the transportation to be provided will consist of four (4) seventy (70) passenger buses to depart from San Diego Jack Murphy Stadium at 8:00 a.m. on June 26, July 3, July 10 and July 17, departing from Camp Palomar on the following respective Fridays; and

WHEREAS, the agreement by the San Diego Unified School District to provide transportation is conditional on the specified terms:

NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:


1. That The City of San Diego will assume total responsibility for the conduct of students while riding the bus, including but not limited to vandalism to school equipment;

liability for damages resulting from objects thrown from the bus;  
and medical expenses for an injury while entering, leaving or  
moving about the bus;

2. That The City of San Diego will bear an equal share of  
the liability over and above insurance limitations if the school  
district meets the following performance standards: all drivers  
are licensed in accordance with the California Vehicle Code for  
transporting school students; all buses are Class A rated,  
meeting all safety regulations prescribed in the Vehicle and  
Education Codes; and that the school district's five million  
dollar (\$5,000,000) insurance policy remains in effect.

3. That the City Manager be and he is authorized and  
empowered to enter into a letter of agreement with the San Diego  
Unified School District reflecting the terms of this resolution.  
This letter agreement is on file in the Office of the City Clerk  
as Document No. RR- 273709.
